


Rolf Oppliger studied computer science, mathematics, and economics at the University of Berne, Switzerland, where he received M.Sc. and Ph.D. degrees in computer science in 1991 and 1993, respectively. In 1994/95, he spent one year as a post-doctoral researcher at the International Computer Science Institute (ICSI) in Berkeley, California (USA).

In 1999, he received the *venia legendi* (also known as "Habilitation" in German-speaking countries) for computer science from the University of Zurich, Switzerland, where he first became a Privatdozent (PD) and was appointed adjunct professor in 2007.



The focus of his professional activities is on technical information security and privacy. In these areas, he has published many books (see righthand side) and scientific articles and papers, regularly participates at conferences and workshops - both as a contributor and a member of program committees, serves on the editorial board of some leading magazines and journals (e.g., IEEE Computer and Security & Privacy), and is the editor of the information security and privacy book series published by Artech House (that currently comprises more than 40 titles).

He is a senior member and distinguished speaker of the ACM, a senior member of the IEEE, a member of the IEEE Computer Society, and a member of the IACR. He also served as vice-chair of the IFIP TC 11 working group on network security.








